1 MR. RUSSELL RINALDI: Good evening,  
2 ladies and gentlemen. I'd like to call the  
3 meeting to order with the Pledge of  
4 Allegiance, please.

5 (The Pledge of Allegiance was  
6 recited.)

7 MR. RUSSELL RINALDI: Roll call,  
8 please, Marylynn.

9 MS. BARTOLETTI: Councilwoman  
10 Avvisato is absent. Councilman Butler?

11 MR. BUTLER: Here.

12 MS. BARTOLETTI: Councilman Febbo?

13 MR. FEBBO: Here.

14 MS. BARTOLETTI: Councilman Hoover?

15 MR. HOOVER: Here.

16 MS. BARTOLETTI: Councilman Notari  
17 is absent, Councilman Lettieri is absent.  
18 Councilman Rinaldi?

19 MR. RUSSELL RINALDI: Here. Once  
20 again, ladies and gentlemen, welcome to the  
21 Old Forge Borough meeting this evening.  
22 Tonight is June 6th. Before we get into our  
23 work session we're going to open up our  
24 meeting which was advertised for the  
25 awarding of the paving project. To open up

1 the special meeting I'm going to need a  
2 motion.

3 MR. HOOVER: I'll make that motion.

4 MR. RUSSELL RINALDI: By Councilman  
5 Hoover.

6 MR. FEBBO: I'll second it.

7 MR. RUSSELL RINALDI: Seconded by  
8 Councilman Febbo. On the question? Public  
9 input? Roll call, please.

10 MS. BARTOLETTI: Councilman Febbo?

11 MR. FEBBO: Yes.

12 MS. BARTOLETTI: Councilman Butler?

13 MR. BUTLER: Yes.

14 MS. BARTOLETTI: Councilman Hoover?

15 MR. HOOVER: Yes.

16 MS. BARTOLETTI: Councilman Rinaldi?

17 MR. RUSSELL RINALDI: Yes.

18 Marylynn, we have three bids?

19 MS. BARTOLETTI: We have four.

20 MR. LOPATKA: Actually five.

21 MR. RUSSELL RINALDI: One was thrown  
22 out?

23 MR. LOPATKA: Well, it was left in  
24 the mailbox and we don't know when it was  
25 put there.

1 MS. BARTOLETTI: No one rang the  
2 door bell, they just left it. So I think  
3 look at what we have. So the lowest bid  
4 came from Pennsy Supply. The base bid plus  
5 the two alternates came to \$664,065.25.

6 The second is New Enterprise, and  
7 their total, the base and the two  
8 alternates, was \$726,173.75.

9 Number three was American Asphalt.  
10 Their total is \$777,777.

11 Number four was Wayco, and their  
12 total is \$829,968. So Dave tabulated and  
13 this is what he came up with for us, and our  
14 solicitor, who wasn't able to come tonight,  
15 reviewed all the bids and he finds  
16 everything in order and we are okay to  
17 approve tonight.

18 MR. RUSSELL RINALDI: Okay.

19 MR. LOPATKA: So I did send Marylynn  
20 a letter recommending Pennsy Supply, that  
21 the bid be awarded to them, but I also  
22 forwarded a copy to Pennsy so they can get a  
23 bond in place.

24 MR. RUSSELL RINALDI: Anything else  
25 before we open up the motion? At this time

1 the chair would entertain a motion to award  
2 Pennsy Supply the 2023 paving project.

3 MR. HOOVER: I'll make a motion that  
4 we award Pennsylvania Supply for  
5 \$664,065.45.

6 MR. RUSSELL RINALDI: By Councilman  
7 Hoover.

8 MR. BUTLER: I'll second it.

9 MR. RUSSELL RINALDI: Seconded by  
10 Council Butler. On the question? Public  
11 input? Roll call, please, Marylynn.

12 MS. BARTOLETTI: Councilman Febbo?

13 MR. FEBBO: Yes.

14 MS. BARTOLETTI: Councilman Butler?

15 MR. BUTLER: Yes.

16 MS. BARTOLETTI: Councilman Hoover?

17 MR. HOOVER: Yes.
